#### **OUR MISSION**

About every seven years the UConn MPH program begins a reaccreditation process, looking at the current accreditation criteria of the Council for Education in Public Health (CEPH) and critically evaluating whether and to what extent we meet these criteria. The first criterion, **Criterion 1.1 Mission**, mandates that every accredited program or school "shall have a clearly formulated and publicly stated mission with supporting goals, objectives and values."

The MPH Advisory Committee, comprised of faculty, staff, students, alumni, and other community partners, begins the self-study process by reviewing the current mission statement and discussing at length how well it fits with what we are currently about and where we want to go as a program. Any suggested changes are posted on the program's website for comment and further discussed by the Advisory Committee. The final version incorporated into the self-study is similarly disseminated.

One requirement of Criterion 1.1, as indicated above, is the "**publicizing [of] program mission**, **values, goals and objectives.**" With this in mind, we think it is worth reminding our public health constituency, particularly our students and faculty, as to what we are all about, so we can keep this mission in mind in all our transactions, both in the

#### classroom and in the community.

Our UConn MPH mission statement begins with a vision statement, which, unlike the mission, is aspirational in nature—we may not ever achieve this vision, but it is what we aspire to as a program. The entire mission statement is below:

Our program's vision is that the University of Connecticut (UConn) Graduate Program in Public Health is an integral contributor to the effort to make Connecticut residents among the healthiest, most productive and satisfied of Americans. Our faculty, students and staff, through efforts in teaching, application, discovery and integration1 of public health theory and practices, are committed to improving the well-being of individuals, here in Connecticut and beyond, through organized, comprehensive, effective and just action.

In furtherance of our program's vision, the mission of the UConn Master of Public Health (MPH) program is to offer an exemplary academic environment that prepares interprofessional learners to achieve high standards of public health practice. Public health careers for the 21st century, along with many in the related health and human services, will require competence in interprofessional practice that coordinates skill sets and perspectives of various disciplines in pursuing effective, comprehensive, systems-level improvements to our environment and social structure. Interprofessional competencies refer to the capacity of individuals and teams to enact knowledge, skills, values and attitudes essential for working together across professions and stakeholder groups to improve outcomes.2

#### MPH ALUMNA JOINS FACULTY



The MPH program welcomes our newest faculty member, **Dr. Angela Bermúdez-Millán, PhD, MPH** (2001), to the Department of Community Medicine and Health Care. Dr. Bermúdez-Millán specializes in the area of community nutrition with a strong interest in

maternal and child health among low-income minority groups. Her academic degrees are in nutrition and public health. She is currently an Assistant Research Professor at the Schools of Medicine and Dental Medicine, Department of Community Medicine and Health Care and Division of Behavioral Sciences and Community Health, respectively. Prior to this, she was the Coordinator of the Community Connections Core for the Connecticut Center for Eliminating Health Disparities among Latinos at the Hispanic Health Council.

Dr. Bermúdez-Millán's current research interest is on food insecurity and its impact on psychological distress, dietary behaviors, sleep quality and metabolic risk. She is currently working with Dr. Julie Wagner in the Eat, Walk, Sleep (Cardiometabolic Lifestyle Program for Cambodian Americans) delivered by Community Health Workers, where she is training the community health workers in food insecurity and nutritional assessment methodologies, and helping with the development and implementation of the nutrition and physical activity lifestyle intervention. She is also a scholar of the Connecticut Institute of Clinical and Translational Science (CICATS), Education, Training and Career Development core Pre-K program. Her upcoming professional goals are to continue conducting research, translating and disseminating health education and contributing to the elimination of health disparities among lowincome minority groups.

In the future Dr. Bermúdez-Millá envisions offering electives in the MPH Program, such as *Food*, *Health and Politics*; *Community-based Participatory Research*; *Nutrition in Health and Diseases*; *Food Safety*; and *Public Health Nutrition*. Looking back on her time as a UConn MPH student, she states,

> It is impossible to maintain the health of our populations without thinking and considering public health. UCONN public health program taught me this and provided me the skills necessary to improve the health of low-income populations, and become a committed advocate for social justice in health.

# FREE SHUTTLE SERVICE TO STORRS



Have you wanted to take a course in Storrs or attend a seminar there, but were unenthusiastic about driving (and parking) there (or lacked transportation)? If so, you may be interested in a new, free shuttle service that started on January 19, which allows UConn Health employees and students to travel easily between Farmington and the Storrs campus each weekday during the spring 2016 semester. Shuttle passengers will be required to reserve a seat online at

www.bus.uconn.edu/#shuttleUCH no later than 3:00 p.m. on the prior day. Passengers will be asked to provide information about whether they are traveling one way or round-trip; indicate their pick-up location, as well as provide a cell phone number so the shuttle driver can be in touch to ensure the best service. Passengers should arrive at the shuttle stop no later than 5 minutes prior to the scheduled departure time with their UConn Health ID badge.

There are three shuttle bus stops at UConn Health located at the Main Road Bus Shelter at Discovery Way (JAX), Main Building Entrance, and the Cell and Genome Sciences Building, 400 Farmington Avenue. The shuttle bus stop at Storrs is located at Jorgensen Center for the Performing Arts, Hillside Road.

The anticipated weekday schedule, subject to traffic and weather conditions, is as follows:

8 a.m.	Depart from Storrs campus
9 a.m.	Arrive at UConn Health –
disembark and	pickup new passengers
10 a.m.	Arrive at Storrs campus
3 p.m.	Depart from Storrs campus
4 p.m.	Arrive at UConn Health - disembark
and pickup new passengers	
5 p.m.	Arrive at Storrs campus

The shuttle service will operate on a trial basis through the end of May. At that time, the schedule and ridership data will be assessed to determine future availability. # STUDENT/STAFF PARKING IN STORRS



To make it easier for UConn Health students on the Farmington campus to attend classes, lectures or other activities in Storrs, those with a parking permit may park in C-lot on the Storrs campus. Similarly,

UConn Health staff may park at the Storrs campus in parking areas equivalent to the parking permit that they have for the Farmington campus. For example, an UConn Health Area 1 permit holder may park in any lots marked Area 1, 2 or 3. UConn Health Area 3 permit holders may only park in lots marked Area 3. #### **CPHA CALL FOR AWARD NOMINATIONS**





There is no greater honor than to be recognized by one's peers. To that end, the Connecticut Public Health Association (CPHA) holds the honor of recognizing individuals and agencies that have demonstrated leadership, and/or have made significant contributions to the public health sector in our state. This year's awards are even more significant as CPHA celebrates its centennial and 100 years of promoting public health in Connecticut.

The CPHA Call for Awards is an invitation to nominate an individual or agency from a traditional or non-traditional public health occupation or sector. The awards are listed below:

The C.E.A. Winslow Award is presented to a public health professional that has demonstrated leadership and achievement in practice, research and/or education. The grant commemorates Charles-Edward Amory Winslow (1877-1957), a pioneer in public health and medicine who is credited with founding the second oldest school of public health in the country at Yale University. Among the most widely quoted health leaders during his lifetime, Winslow believed that equal weight with scientific ideas about health and disease was a commitment to social justice—that social ills must be the first conquest in the "conquest of epidemic disease."

The Ira V. Hiscock Award recognizes a Connecticut layperson OR organization that has made notable contributions to the advancement of public health through public service, education, advocacy and/or leadership. Hiscock was an internationally recognized epidemiologist and public health professor at Yale who inspired generations of students.

**The Charles G. Huntington III Award** recognizes a health care practitioner who has demonstrated public health leadership and a commitment to the health and well-being of populations. Huntington was a leader, a role model, a dedicated humanist, a steadfast public health advocate, and a caregiver of the first order. Believing that physician assistants are critical to meeting our nation's health care needs, he did much to advance the profession and served as the president of the American Academy of Physician's Assistants. He provided leadership to CPHA, serving as president for three years. At the time of his passing, Charles was an Associate Dean and Associate Professor at the UConn School of Medicine. He was an instructor in the MPH program and served as an advisor to several students.

The Michael J. Perlin Student Award recognizes a current public health student who demonstrates, through student activities and/or community service, a commitment to leadership, volunteerism, and the highest educational standards. At the time of his passing, Dr. Michael Perlin was Professor Emeritus of Public Health at Southern Connecticut State University, where he distinguished himself as a respected educator, colleague and public health advocate. During his 41 years in education, Perlin was known as an energetic and ingenious teacher, who left an indelible mark on countless students. He was the 2009 recipient of the C.E.A. Winslow Award. Jonathan Noel, MPH (2009), a student in the UConn doctoral program in public health, was the 2015 recipient of the Perlin Award.

To submit a nomination, use the <u>Call for Awards</u> <u>Nomination Form</u>. All nominees will be evaluated on their strengths, talents and abilities, as well as on their contributions to public health in Connecticut. Anyone is welcome to submit a nomination, even individuals who are not members of CPHA..

The deadline to submit the 2016 CPHA Call for Awards Nomination form to <u>cpha@cpha.info</u> is **Friday, February 26, 2016.** The CPHA Awards Committee will review all nominations and select award recipients to be acknowledged during the CPHA Awards Event that will take place on Friday, April 8, the last day of National Public Health Week. #### HEALTH COMMUNICATIONS INTERNSHIP

The National Cancer Institute (NCI) has recognized that health information dissemination is key in raising public awareness about new cancer treatments, support for cancer patients and their families, and prevention strategies. To that end, in 1975 the NCI established the **Health Communications Internship Program (HCIP)** to attract and develop individuals interested in careers in health communications and science writing.

The HCIP gives highly qualified graduate students and recent graduate degree recipients the opportunity to participate in vital health and science communications projects in one of the many offices that make up the NCI. Interns select one of two areas of emphasis: **Health Communications** or **Science Writing**. Six-month and one-year internship terms are available.

Health Communications applicants should have some science background as well as experience and/or education in any of the following areas: public health, epidemiology, public relations, health education, communications, science writing, statistics, social marketing, or journalism. Health Communications interns: will have the opportunity to:

- Plan, develop, and promote cancer education programs and materials (including Web-based) for the public, cancer patients, or health professionals
- Gain experience in pre-testing and evaluating cancer prevention and treatment messages, publications, materials, and programs that reach the American public
- Participate in professional meetings and training seminars

Science Writing applicants should have a science background with the ability to translate complex scientific concepts into material suitable for a lay audience. Science Writing interns will have the opportunity to:

- Write fact sheets and press releases
- Answer inquiries from the press
- Attend and report on scientific meetings
- Write feature length, creative articles on the latest, most important advances in cancer research
- Participate in professional meetings and training seminars

The Association of State and Territorial Health Officers (ASTHO) has an opening for an Intern in Injury Prevention and Behavioral Health. The intern will work with ASTHO's Health Improvement team to support improvements in state prevention policies and practices, as well as increased alignment of state and federal strategies to reduce the burden of injury and improve health outcomes.

The primary responsibilities of the intern are to:

- Track ongoing and emerging issues relevant to injury and violence prevention efforts and policy issues with some specific focus on the prevention of sexual violence.
- Assist with drafting of newsletter stories, policy or position statements, fact sheets, and reports
- Assist in collecting and disseminating stories from the field
- Conduct literature reviews and prepare fact sheets, issue briefs, and other written materials on specified topics

# **PUBLIC HEALTH DATA ANALYST**

Under general supervision, the Data Analyst performs analytical work of considerable difficulty in health care information management and reporting. Responsibilities include:

- Analyze public health demographic data to identify and quantify public health issues and assist the PHSD in developing strategies to meet the demands of complex and interconnected public health issues
- Perform health assessments and track health issues and trends
- Develop specialized analysis tools, including the use of Geographic Information Systems (GIS) and Statistical Analytic Software (SAS).

Positions at this level are assigned a broad range of duties and may supervise others. The employee has considerable responsibility in the area of data management and analysis affecting the operations and planning of public health activities within the Public Health Services District (PHSD).

The 2016 Annual Meeting and Expo of the American Public Health Association (APHA) will be held in Denver on October 29-December 2, and the organization invites public health professionals, faculty and students to become presenters by submitting an abstract. Abstracts are currently being accepted, with deadlines ranging from February 22-26, depending on topic area.

- Roundtable Sessions small group discussions where presenters can speak directly to attendees in a more intimate setting.
- Poster Sessions visual representation of research and findings where presenters can interact one-on-one with attendees.

You do not have to be an APHA member to submit an abstract. However, if your abstract is accepted for presentation, the presenting author MUST become an APHA individual member and MUST register for the Annual Meeting by the preregistration deadline.
