The spring 2015 Semester begins on **Tuesday, January 20, and Add/Drop** ends on Monday, February 2. If you have not registered yet, please complete the self-registration process in your PeopleSoft Student Admin account using the link below:

FIELD EXPERIENCE IN PUBLIC HEALTH

The Office of Public Health Systems Improvement at the CT Department of Public Health is seeking a student intern to work from January 2015 through May 2015 to assist the Accreditation Coordinator in making the staff more aware of and familiar with the accreditation process currently being undertaken. The primary tasks of the intern are:

 Work with Accreditation Coordinator to develop various communication messages to distribute throughout the agency for greater awareness and understanding of public health accreditation, agency activities, and the need for staff participation and cooperation. CDC/CSTE APPLIED EPI FELLOWSHIP



The Council of State and Territorial Epidemiologists (CSTE), in close collaboration with the Centers for Disease Control

and Prevention (CDC), the Association of Schools and Programs of Public Health (ASPPH), and the Health Resources and Services Administration (HRSA), is currently accepting applications for the Applied Epidemiology Fellowship Program. This program, established to train recent graduates in the expanding field of applied epidemiology, is designed for recent or impending master's or doctoral-level graduates in epidemiology or a related field who are interested in the practice of public health at the state or local level. While the program provides rigorous training for its participants, it is also designed with flexibility in order to meet the particular interests of the fellow. Fellows are matched to a state health department for a two-year fellowship position based on program area of interest.

Fellowship program areas include:

- Chronic Diseases
- Environmental Health (including Waterborne Diseases)

- Infectious Disease (including Healthcareassociated Infections, Quarantine, and Food Safety)
- Injury Prevention (including Drug Overdose)
- Maternal and Child Health
- Occupational Health
- Oral Health
- Substance Abuse

Closely designed based on the Epidemic Intelligence Service (EIS) program and using a mentorship model, the CDC/CSTE Applied Epidemiology Fellowship offers the opportunity for graduates to acquire and develop epidemiologic skills through on-the-job training. Fellows work closely with highly trained and experienced epidemiologists at the state and local level as well as those working at the federal level with the CDC.

The deadline to submit applications is **January 9**, **2015**. All application materials must be received by the deadline to be considered for acceptance. Incomplete applications or applications received after this deadline will not be considered.

MANAGEMENT POSITION



The American Heart Association is seeking a **Director** for its Mission: Lifeline program, which ensures that all patients get the best treatment for heart attack care no matter where they live. This position would help

communities ensure that from the time a 9-1-1 call is placed, the ambulance knows where to take the patient and hospitals in turn know how to treat and triage the patient appropriately.

The Director position provides an opportunity for a public health professional to impact care on a population level. The Director will work with all stakeholders, from EMS, to Fire Departments to hospitals to make sure that the system operates effectively and efficiently. This involves working with partners to collect and analyze data and revise

protocols or make needed change, community by community.

This position encompasses all facets of public health--community, data, communication, evaluation and monitoring. It is based in Waltham, MA but can also be done from Providence, RI or Wallingford, CT. Coverage is all of New England.

The position is grant funded for two years from date of hire. However, there is a strong chance of further funding as well as the possibility of this role becoming a non-grant funded position. The Director will have the opportunity to seek funding and impact the continuation of this role.

RESEARCH ASSISTANT POSITION

Community Health Center, Inc. (CHC) in Middletown, CT is searching for a Research Assistant to work at the Weitzman Research Center on Rewards to Quit (R2Q), a state-wide research project being conducted in collaboration with Connecticut's Medicaid provider and the Yale School of Public Health to increase smoking cessation rates in Connecticut's Medicaid population. Funded through a federal grant from the Centers for Medicare and Medicaid Services, R2Q is investigating what effect financial incentives have on participation in smoking cessation resources and in overall cessation.

The Research Assistant will focus on enrollment, recruitment, data collection and management, and participant service and satisfaction at CHC's 12 primary care sites. The Research Assistant will also be expected to run process and planning meetings, report data, and manage the smoking cessation program and services provided at CHC.

SOCIAL WORK POSITION

Integrated Health Services (IHS), a non-profit organization operating School Based Health Centers (SBHCs) in the East Hartford public school system, is seeking a licensed social worker (LCSW) to join its team at the elementary school level. The person in this position will provide ageappropriate counseling to students in need of behavioral health care services. DISPARITIES SEMINAR

The Connecticut State Medical Society (CSMS) and the Connecticut Health Foundation will present a symposium, **Racial and Ethnic Disparities in Readmission Rates**, on Wednesday, **February 4**, 2015, 8:30 a.m.-4:30 p.m. at Four Points by Sheraton, Meriden, CT. The purpose of the symposium is to present the culmination of research findings, and provide a forum to integrate stakeholder interpretations into practice models of care delivery to reduce the level of inequity tied to hospital readmission.

The symposium is based on research conducted by CSMS over the last two years which found significant and pronounced disparities in the readmission rates of Black and Latino patients compared to White patients involving nine out of 10 major diagnostic categories (MDCs). The outcome of the symposium will be to document potential best practices of the conditions with the greatest health disparities identified in the CSMS study:

- Uncomplicated Delivery
- Joint Replacement Surgery
- Heart Failure& Chest Pain
- Digestive Disorders

The symposium is designed for health care policy makers, regulators, hospital administrators, physicians and other healthcare professionals and providers.
